

'05 Murder Conviction Overturned

An Appeals Court overturned the murder conviction of P.C., who was accused of killing his wife, whose body was discovered inside her sport-utility vehicle in a remote area of the PNC Arts Center in Holmdel in 2005. In 2008, G.C. was sentenced to 50 years in prison after he was convicted of the murder. Norm Hobbie and Ted Bertucio filed an appeal of the conviction, arguing that the trial court had committed a number of

reversible errors regarding the admission of evidence, which resulted in an unfair trial. This summer, the Appellate Division reversed the 2008 conviction, and ruled that the admission of the evidence at issue warranted reversal of the murder conviction, and remanded the case for a new trial. The State has filed an appeal to the State Supreme Court where the matter remains pending.
